



**Water Rates and Charges Effective January 1, 2025 (OMC: 13.16)**  
(Approved March 14, 2023 Resolution No. 11437)

**Water Service Charges**

**Standard Charges**

There are two standard water service charges paid by all customers: a service capacity charge which is a flat rate based on the size of the water meter, and a water consumption charge which is based on the amount of water used.

**Service Capacity Charge (bi-monthly)**

This fixed charge is based on the size of the water service connection:

**Water Consumption Charge (bi-monthly)**

This charge is based on water usage. The metered water usage billed in units of 100 cubic feet (hcf) is applied to a tiered rate structure. *Note that the cost for water will be lower if less water is use.*

**Penalty Fee**

A 10% fee will be added to water charges that have an unpaid balance 30 days after the billing due date for services rendered.

**Late Service Fee**

An account that remains unpaid approximately 60 days after services are rendered will be assessed a service late fee and is subject to disconnection.

**Other Charges**

**Elevation Charge (bi-monthly)**

Only residents living at higher elevation zones pay this charge. It covers a portion of the cost to pump water to these service zones:

**Private Fire Service Charge (bi-monthly)**

Only customers with a private fire service connection pay this charge. It covers the cost of providing water system fire flow capacity and maintenance, and varies by the size of the private fire service:

**Pass-Through**

Because a significant portion of the City's water rates are heavily influenced by costs assessed against the City by outside agencies, the City Council directed the review of a potential pass-through charge to account for these agency's unanticipated future increases or decreases. Government Code Section 53756 authorizes agencies to adopt a schedule of fees or charges authorizing automatic adjustments that pass-through increases in wholesale charges for water and adjustments for inflation for a period of five (5) years. The amount of automatic adjustments (Pass-Through Charges) to account for changes in wholesale water costs will be based directly on the incremental difference in costs that the City will incur from these other agencies as a result of increases or decreases in the amount such agencies charge the City. Any such adjustments will only be made to the extent such increases or decreases are not already reflected in the schedule of charges then in effect. Data documenting the amount of the increase or decrease in water commodity costs and the basis for all adjustment calculations will be made available to the public upon request at the time of any automatic adjustment. Volumetric usage charge component of the water used and will be assessed on all hcf's used by a customer. A notice of at least 30 days will be provided to customers before any such adjustments will take effect. The formula for which the automatic pass-through charge is calculated is as follows:
